



## Financial Commitment

*Thank you for considering the enrollment of your child at South Christian High School!  
We are proud of our Christ-centered education.*

A Christian Education is a major financial commitment. Below are some facts about our tuition system.

- The current annual tuition is \$883 per month (11 monthly payments, totaling \$9,710)\*
- Parents make their payments to FACTS Management Company and can choose from a variety of payment plans (One annual payment in August, Two payments in August and January, Quarterly payments in August, October, January and March or Monthly payments, August – June).
- Tuition must be paid in full each year before a child will be reenrolled for the following year.
- Parents must sign the enrollment form and choose a payment plan with FACTS before a child begins classes and agree to these terms:

*"I promise to pay the above tuition in accordance with the tuition schedule that I will indicate to FACTS. I understand that if a family misses a payment for 2 consecutive months and does not communicate with the business manager, the parents and student(s) will be notified by email and letter and will have 7 days to make up the missed payments or the student will not be allowed to attend South Christian until the payments are received. I understand that if I do not meet the above terms, the school may also take one or more of the following steps: communicate with my church; withhold report cards, transcripts and diplomas; refuse to allow my student(s) to take exams, participate in extra-curricular activities, or attend SCHS; deny participation in graduation ceremonies; initiate legal action to collect tuition due. I understand that I must abide by the above tuition payment schedule unless I reach an alternate written agreement with the school's Finance Committee. I agree to reimburse the school for any actual attorney fees incurred as a result of my failure to pay tuition as due. **I agree that a fee of \$30 will be charged to my/our account for any payment made by me/us that is returned for insufficient funds.** I will make full payment of any prior years' tuition by August 1, 2023 unless I enter into an alternate written agreement with the school's Finance Committee. Until payment is made or an alternate written agreement is approved, enrollment is considered 'conditional,' **and any of the above-listed actions may be taken by the school if payment is not made. I/We understand that rules of the Michigan High School Athletic Association forbid student participation in or try out for a team sport unless formally enrolled. Coaches are not allowed to make exceptions.***

- If you are transferring in after a school year has started, a deposit equal to two months tuition must be received before your child can attend their first class.

We do realize that unfortunate circumstances may arise. In the event of a hardship, you will be required to follow these steps.

- You will be required to meet with the Finance Committee to discuss your situation and create an acceptable payment plan.
- If you qualify, there is financial assistance available. You must apply at <https://online.factsmgt.com/signin/3D23W> and will be required to submit your income tax returns.
